ELIGIBILTY TO ATTEND BASED ON THE RECORD OF DEPOSITORS

Only shareholders or members whose name appears on the Record of Depositors as at 25 November 2025 shall be entitled to attend, participate, speak and vote at the 23rd AGM or to appoint proxy(ies) or corporate representative(s) to attend, participate, speak and vote on his/her behalf.

REGISTRATION

- The registration for the 23rd AGM will start at 8:00 a.m. at the Meeting Venue and will remain open until the conclusion of the 23rd AGM or such time as may be determined by the Chairman of the Meeting.
- 2. Please read and follow the signage placed around the Resort as to where you should register for the 23rd AGM.
- 3. Please produce your ORIGINAL MyKad (for Malaysian)/ Passport (for foreigners) during registration for verification purpose. Kindly ensure that you collect back your MyKad/Passport after registration.
- 4. Registration must be done in person. No person is allowed to register on behalf of another even with the original MyKad/Passport of the other person.
- 5. After verification and registration, you will be given an Identification Wristband. No one will be allowed to enter the Meeting Venue without wearing the Identification Wristband. Please note that there is no replacement for the Identification Wristband if it is lost or misplaced.
- 6. Please approach our help desk personnel for any enquiry or clarification.

APPOINTMENT OF PROXY(IES)

- 1. If you are unable to attend the 23rd AGM, you may appoint your proxy(ies) or the Chairman of the 23rd AGM as your proxy. Kindly indicate your voting instructions in the Form of Proxy and complete the Form of Proxy in accordance with the notes and instructions printed therein.
- 2. If you wish to participate at the 23rd AGM, you must not submit any Form of Proxy. You will not be allowed to participate in the Meeting together with proxy(ies) appointed by your good self.
- 3. The completed original Form of Proxy must be deposited at the office of the Share Registrar of the Company, Berjaya Registration Services Sdn Bhd at 09-27, Level 9, Berjaya Times Square, No. 1 Jalan Imbi, 55100 Kuala Lumpur OR alternatively, the Form of Proxy may be submitted electronically ("E-Proxy Lodgement") via Berjaya Registration Portal at https://www.berjayaregistration.com.my, not less than forty-eight (48) hours before the time set for holding the 23rd AGM or at any adjournment thereof, the last date and time being, Sunday, 30 November 2025 at 10:00 a.m. For E-Proxy Lodgement, kindly refer to the guidelines as set out in Appendix A.

REVOCATION OF PROXY

1. If you have submitted your Form of Proxy either in hard copy or by electronic means prior to the 23rd AGM, and subsequently decide to appoint another person or wish to personally attend and participate at the 23rd AGM, please write to the Share Registrar at shareq@berjayareg.com.my to revoke your earlier appointment of proxy(ies) at least forty-eight (48) hours before the 23rd AGM, i.e. no later than 10:00 a.m. on Sunday, 30 November 2025. Upon revocation, proxy(ies) appointed earlier will not be allowed to participate at the 23rd AGM. In such an event, you should advise your proxy(ies) accordingly.

VOTING PROCEDURE

- 1. Pursuant to Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, the voting at the 23rd AGM will be conducted by poll. The Company has appointed Berjaya Registration Services Sdn Bhd as Poll Administrator to conduct the poll voting and Symphony Corporate Services Sdn Bhd as independent scrutineers to verify and validate the poll results.
- 2. The poll voting will be conducted electronically. The Poll Administrator will distribute a voting device to each attendee upon entering the Meeting Venue. Attendees are required to return the voting device to the Poll Administrator before leaving the Meeting Venue.

1. Prior to 23rd AGM

Steps (applicable for individual shareholders ONLY)
